I. BACKGROUND

On November 7, 2011, US Connect LLC (Company) filed a petition for designation as an eligible telecommunications carrier in the State of Utah, requesting expeditious review. Thereafter, the Commission entered an order granting a stay on February 22, 2012. On March 11, 2013, the Commission issued an Order to Show Cause and Notice of Hearing for March 27, 2013. Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
