17.5.1 General

The Company will be transitioning terminating access rates according to the Federal Communication Commission's USF/ICC Reform Order issued on November 18, 2011. Terminating switched access will transition from Non-LTR Rate Design to LTR Rate Design for a transition period beginning July 1, 2012 through June 30, 2013. Terminating End Office access elements will transition from their current levels to zero between July 1, 2012 through June 30, 2020. Accordingly, the Rate Table in Section 17.4.2 below reflects the rates that will become effective on July 1st of each year during the transition period until the end of the transition period.
