This filing proposes two changes:

- To revise the State Access Tariff to address the Identification and Rating of Voice over Internet Protocol-Public Switched Telephone Network (VoIP-PSTN) toll traffic, which is in accordance with the FCC's Order 11-161 effective on December 29, 2011. VoIP-PSTN toll traffic would be billed at the interstate switched access rates, which are lower than the current state access rates.
- 2. To revise the Carrier Common Line rate as required in the FCC's November 18, 2011 Report and Order and Further Notice of Proposed Rulemaking in WC Docket Nos. 10-90, etc. (FCC 11-161). The rate change is in accordance with Section §51.909, Transition of rate-of-return carrier access charges of that Order.

Even though the other rates were not changed at this time, we changed the text to indicate originating and terminating rates in case the originating rates remain capped in the future.

We are also doing tariff clean up on the Check Sheet for missing sheet numbers.

It is requested that this filing become effective July 3, 2012.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with other Tariff sections.
