The CPCN allows Covad to provide switched and dedicated, local intraexchange and interexchange services, both facilities based and resold, within the State, subject to intrastate competition from CenturyLink, formerly U.S. West Communications, Inc., and other certified local exchange carriers. <u>See id.</u> at 2, ¶ B and 3, ¶ I. The CPCN further obligates Covad to comply with the provisions contained in Exhibit B attached to the order, which includes an annual report filing requirement. <u>See id.</u> at 3, ¶ L.

On December 14, 2012, Covad filed a notice to change its name to MegaPath Corporation ("MegaPath"). Attached to its name change request is a copy of MegaPath's amended corporate filing. <u>See</u> Name Change Request, filed December 14, 2012.

On December 21, 2012, the Division of Public Utilities ("Division") filed a memo recommending the Commission acknowledge the name change and make any other necessary changes. <u>See</u> Division Memo, filed December 21, 2012. The Division notes the name change will neither impact Utah customers nor change the services offered. <u>See id.</u>
