("360networks") moving to Zayo Group, LLC ("Zayo"). On March 26, 2013, Zayo filed notice of consummation of the above transaction and requested to cancel 360networks' certificate of public convenience and necessity (CPCN No. 99-2289-01).

In its March 26, 2013 filing, Zayo states: "As a result of the Zayo Pro Forma

Transactions, 360networks . . . do[es] not exist as [a] separate corporate entit[y] and Zayo

provides service to [its] customers. ... [T]herefore, the [c]ertificate ... should be cancelled....."
