This matter is before the Commission upon the recommendation of the Division of Public Utilities (“Division”), dated August 28, 2012, concerning Certificate of Public Convenience and Necessity (CPCN) No. 2453. The Division recommends cancellation of the CPCN based on the request of Chase Com to cancel its CPCN, filed July 31, 2012.

On July 13, 2005, the Commission issued CPCN No. 2453 to Chase Com. The Division notes that the business license for Chase Com expired in 2011 for failure to renew, and Division records show Chase Com has not had any business revenue in the State of Utah for the past three years.

For the foregoing reasons, Certificate No. 2453, issued July 2005, is hereby canceled.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
