NOTICE

On July 30, 2012, Broadview Networks, Inc. ("Broadview Networks" or "Applicant") filed an application for Commission approval to complete a transaction involving the transfer of indirect control of Broadview Networks to Broadview Networks Holdings, Inc. ("Broadview Holdings"). Applicant seeks informal adjudication of the application pursuant to Utah Administrative Code R746-349-7.

Parties should plan to be represented by local counsel, joined by local counsel, or otherwise admitted by a motion *pro hac vice* pursuant to Commission rules (Utah Admin. Code R746-100-6(B)).
