3. Q LINK WIRELESS LLC ("Q LINK") is petitioning to provide public

telecommunications service in URTA members' service territories, which include areas served

by rural telephone companies.

4. Under 47 USC § 214(e)(2), the Commission must determine if such designation is

in the public interest.

5. URTA and URTA members, therefore, have a significant interest in the above-

captioned matter and their legal interests may be substantially affected by the outcome.

6. The interests of justice and the orderly and prompt conduct of this proceeding will

not be materially impaired by allowing URTA to intervene.
