MOTION TO WITHDRAW

True Wireless LLC (“True Wireless”), by counsel, files this motion to withdraw its Petition for Designation as an Eligible Telecommunications Carrier Pursuant to 47 U.S.C. § 214(e) in the State of Utah (the “Petition”). True Wireless respectfully moves that the Public Service Commission of Utah (“Commission”) terminate this proceeding without prejudice to True Wireless’ re-filing at a later time.

True Wireless filed its Petition on July 16, 2012. Under the *Lifeline Reform Order* issued by the Federal Communications Commission (“FCC”), True Wireless was required to submit a Compliance Plan to the FCC.<sup>1</sup> The Commission suspended this docket on August 13, 2012 until such time as the FCC approved True Wireless’ compliance plan. True Wireless submitted its Fourth Amended Compliance Plan on December 7, 2012.<sup>2</sup> More than 16 months later, approval of that plan remains pending. Accordingly, True Wireless has decided to withdraw its Petition.

True Wireless intends to await FCC approval of its Compliance Plan, and then file an updated petition for designation with this Commission.
