Dear Mr. Widerburg:

Blue Jay Wireless, LLC (Blue Jay or the Company) has been designated by the Utah Public Service Commission (Commission) as an Eligible Telecommunications Carrier for the provision of wireless Lifeline services.<sup>1</sup> In its application, Blue Jay stated that it would provide, among others, the following tribal Lifeline offerings in Utah:

- 1000 anytime voice minutes/texts without rollover and with text messaging assessed at a rate of 1 minute per text message for sending and one minute per text message for receiving text messages, at a charge of \$1.00 per month; and
- Unlimited voice minutes (no texts) at a charge of \$5.00 per month.

- Unlimited voice and text at no charge;
- Unlimited voice and text plus 500 MB of data for a charge of \$5.75 per month; or
- Unlimited voice and text plus 5 GB of data for a charge of \$14.75 per month.

A revised Utah-specific fact sheet reflective of this change is enclosed with this notice.

Blue Jay's marketing of the modified plan will be implemented consistent with any necessary state notices and regulatory approvals. In accordance with the Order granting Blue Jay's ETC application, it is the Company's understanding that no further notice or approval is required from the Commission in connection with this modification.
