Bresnan Broadband of Utah, LLC ("<u>Bresnan Utah</u>"), through its undersigned counsel and pursuant to Utah Code Ann. §§ 54-4-28, 54-4-29, 63G-4-203 and Utah Admin. Code R746-349-7, requests Utah Public Service Commission (the "<u>Commission</u>") approval, through informal

adjudication, of a transaction that will result in the indirect transfer of control of Bresnan Utah, a Utah competitive local exchange carrier, to Charter Communications, Inc. ("Charter").

I. INTRODUCTION

1. Introduction of the Parties

Bresnan Utah is a limited liability company organized under the laws of the State of Utah with its principal place of business in Cedar City, Utah. Bresnan Utah is a wholly-owned subsidiary of Cablevision Systems Corporation ("Cablevision"), which in conjunction with its subsidiaries, provides video, voice, broadband and business services to approximately 3.6 million customers in New York, New Jersey, Connecticut, Colorado, Wyoming, Montana and Utah. Bresnan Utah holds a certificate of public convenience and necessity issued by the Commission to provide local exchange telecommunications services in and around Cedar City, Utah. ¹

Charter is a leading broadband communications company with operations in 25 states and is the fourth largest cable television system operator in the United States. Through its operating subsidiaries, Charter offers a variety of entertainment, information and communications solutions to residential and commercial customers, including traditional cable video programming (basic and digital video), high-speed Internet services, and telephone services.

Charter possesses significant experience in the successful operation of telecommunications services providers as demonstrated by Charter's existing operation of 24 separate state-level telephone operating companies serving approximately 1.9 million telephone customers. With respect to its telephone operations, Charter currently offers a full array of local exchange, long distance, private line, and interconnected VoIP services to customers in Alabama, California, Connecticut, Georgia, Illinois, Louisiana, Massachusetts, Michigan, Minnesota, Missouri, Nebraska,

Nevada, New Hampshire, New York, North Carolina, Oregon, South Carolina, Tennessee, Texas,

Vermont, Virginia, Washington and Wisconsin. Charter's telephone operating subsidiaries utilize a

dedicated telephone staff that is knowledgeable and experienced in all areas of telephone system

management, including finance, operations, regulation, engineering, networking and sales, to

oversee their respective telephone operations.

The indirect transfer of control will result from the proposed acquisition of the membership

units of one of Bresnan Utah's parent companies, Bresnan Broadband Holdings, LLC ("Bresnan

Broadband"), by Charter Communications Operating, LLC ("Charter Operating"), a subsidiary of

Charter. As a result of the transaction, Bresnan Broadband will become a subsidiary of Charter,

giving Charter indirect control of Bresnan Utah. No immediate changes to Bresnan Utah are

anticipated as a result of the indirect transfer of control, and the company will continue to operate

subject to the requirements contained in the certificate issued to it by the Commission.

As required by Utah Admin. Code R746-349-7, Bresnan Utah provides the following information:

Bresnan Utah certifies that it is not an incumbent local exchange carrier in Utah or in any other location.

2. Identification that Applicant Seeks Approval of the Application Pursuant to Utah Admin. Code R746-349-7.

Bresnan Utah declares that it is seeking approval of this application pursuant to Utah Admin. Code R746-349-7.

3. Description of the Transaction for Which Approval is Sought.

On February 7, 2013, Charter Operating, a subsidiary of Charter, entered into a Purchase Agreement (the "<u>Agreement</u>") with CSC Holdings, LLC, a wholly-owned subsidiary of Cablevision, pursuant to which Charter, through Charter Operating, agreed to acquire Bresnan Broadband and its

subsidiaries, including Bresnan Utah, from Cablevision on the terms and subject to the conditions set forth in the Agreement.

Upon completion of the transaction, Charter Operating will own 100% of the Bresnan Broadband membership units. The prior interest in Bresnan Broadband and its subsidiaries held by Cablevision and its subsidiaries or affiliates will be extinguished. Charter, through Charter Operating, will pay a cash purchase price to Cablevision for Bresnan Broadband and its subsidiaries of \$1.625 billion, subject to a working capital adjustment and certain other reductions or adjustments as set forth in the Agreement. Because Bresnan Utah is a wholly-owned, indirect subsidiary of Bresnan Broadband, the change in control of Bresnan Broadband will result in the indirect change of control of Bresnan Utah. Accordingly, after the completion of the transaction, Bresnan Broadband and its subsidiaries, including Bresnan Utah, will become indirect subsidiaries of Charter. The transaction closing is expected to occur after all necessary regulatory approvals have been obtained.
