**REQUEST FOR SUSPENSION OF
SCHEDULE AND FOR HEARING ON
STIPULATION**

Tempo Telecom, LLC (“Tempo”), through its counsel, and based on the information set forth below, hereby requests the Utah Public Service Commission (“Commission”) to suspend the schedule in this docket and set this matter for hearing on the Settlement Stipulation.

1. On December 12, 2013, Tempo filed its Petition for Designation as an Eligible Telecommunications Carrier in Utah (“Petition”). The Division of Public Utilities (“Division”) filed comments on January 6, and again on January 17, 2014, and a Scheduling Order was issued on January 29, 2014. Tempo filed direct testimony in support of the Petition on February 12, 2014.

2. Subsequent to the filing of Tempo’s direct testimony, the Division, the Office of Consumer Services (“Office”) and Tempo engaged in settlement discussions and, as a result, have

reached a Settlement Stipulation, filed concurrently herewith, signed by counsel for Tempo, the Division and the Office.

3. Other than the Division and the Office, there have been no interveners in this docket, and the time for requesting intervention expired on February 21, 2014.

Based on the forgoing, Tempo respectfully requests that the Commission suspend the schedule in this docket and set the matter for hearing on the Settlement Stipulation at the Commission's earliest convenience.
