Dear Ms. Orchard:

JSI files the enclosed tariff material on behalf of Central Utah Telephone, Inc. and Subsidiaries Intrastate Access Tariff P.S.C. Utah No. 2 issuing carriers (issuing carriers) listed at Appendix A. Proposed revisions are made in compliance with current Federal Communications Commission (FCC) rules governing intercarrier compensation. The proposed revisions bear an effective date of July 1, 2014. An original and two (2) copies are provided as well as an electronic copy.

Proposed rates reflect the step down of End Office terminating rates as prescribed by FCC rules. Further, NECA interstate switched access rates are expected to increase effective July 1, 2014, thereby increasing the capped rates which the issuing carriers must match for terminating access by July 1, 2014. Rates are based on illustrative rates provided by NECA on April 29, 2014 (see Exhibit 1). If NECA rates approved by the FCC differ from the issuing carrier rates proposed in this filing, rates will be adjusted to match the approved NECA rates. Issuing Carriers' interstate terminating switched access rates are contained in NECA Tariff F.C.C. No. 5 which may be found at https://www.neca.org/Tariff_5.aspx.
