ADMINISTRATIVE LAW JUDGE REIF: Good evening every one I am Melanie Reif with the Utah Public Service Commissioner. I serve as the Administrative Law Judge for the Commission. This evening, we are having the public witness hearing, in docket 14-043-01. This matter was originally set as a rate increase hearing and, subsequently, was heard as a stipulation hearing earlier today. So this evening is the date and time for the public witness portion of the hearing, and let's start by taking the appearances.

MS. SLAWSON: Kira Slawson from Blackburn and Stoll, on behalf of Gunnison Telephone Company, and with me, I have Natalie Gleave.

ADMINISTRATIVE LAW JUDGE REIF: Ms. Slawson, will Ms. Gleave provide testimony this evening?

MS. SLAWSON: She can provide testimony regarding the notice but we also have copy of the notices.

ADMINISTRATIVE LAW JUDGE REIF: Excellent, thank you very much.

MR. JETTER: Justin Jetter for the Utah Public Division of Utilities.

ADMINISTRATIVE LAW JUDGE REIF: And Mr. Jetter will you be calling a witness this evening?



1	MR. JETTER: I will not.
2	ADMINISTRATIVE LAW JUDGE REIF: Okay.
3	MS. MURRAY: Cheryl Murray with the Office
4	of Consumer Services, and I am just here to sign anyone
5	up who wants to speak.
6	ADMINISTRATIVE LAW JUDGE REIF: Thank you,
7	Cheryl. I appreciate you being here.
8	And, sir, Mr. Sanders on the telephone,
9	could you please identify yourself for the record?
10	MR. SANDERS: This is Kim Sanders. I am the
11	president and manager, or the general manager, of the
12	Gunnison Telephone Company.
13	ADMINISTRATIVE LAW JUDGE REIF: Okay. And
14	do you wish to provide testimony or comment this
15	evening, sir?
16	MR. SANDERS: I don't.
17	ADMINISTRATIVE LAW JUDGE REIF: Okay, so you
18	are on the line to listen and observe; is that correct?
19	MR. SANDERS: Yes.
20	ADMINISTRATIVE LAW JUDGE REIF: Okay, very
21	good.
22	MR. SANDERS: Natalie Gleave is there
23	representing the company.
24	ADMINISTRATIVE LAW JUDGE REIF: Okay, thank
25	you. You may hold the line, sir.





1	Ms. Slawson, let's start with you and with
2	the exhibit that you mentioned in your opening.
3	MS. SLAWSON: We actually have two exhibits
4	because as you know, there was originally a hearing set
5	for September, and so the first exhibit that we have is
6	the notice that was first sent out by the company, and I
7	guess I will have Ms. Gleave authenticate that, if that
8	works for the Commission.
9	ADMINISTRATIVE LAW JUDGE REIF: Either way
10	is fine.
11	MS. SLAWSON: Okay. I will proffer this
12	first exhibit was provided in the customers' bill on
13	July 1st of 2014.
14	ADMINISTRATIVE LAW JUDGE REIF: Thank you.
15	Do you have a copy for the reporter?
16	MR. JETTER: She can have my clean copy.
17	ADMINISTRATIVE LAW JUDGE REIF: Thank you,
18	that would be great. We will make that part of the
19	transcript. How did you want that to be marked?
20	MS. SLAWSON: We can mark that as Gunnison
21	Telephone Company Exhibit 1, Hearing Exhibit 1. Then I
22	also have what we would like marked as Gunnison
23	Telephone Company Hearing Exhibit 2.
24	(Exhibits No. 1 & 2 were marked for
25	identification.)



1	ADMINISTRATIVE LAW JUDGE REIF: Thank you.
2	MS. SLAWSON: And this notice was provided
3	to the customers in their August 1st bill. This notice
4	also appears on the has appeared on the website since
5	August 1st and is currently on the website now, and has
6	also been a handout that customers can take when they
7	come into the office, and, finally, it was posted in the
8	office when customers appeared. And it shows that the
9	date and time for the public witness hearing is five
10	o'clock on August 19, 2014, room 454, Heber M. Wells
11	Building, Salt Lake City, Utah.
12	ADMINISTRATIVE LAW JUDGE REIF: Thank you,
13	Ms. Slawson.
14	MS. SLAWSON: We don't have anything
15	further.
16	ADMINISTRATIVE LAW JUDGE REIF: Okay, give
17	me just one moment. We will be off the record.
18	(A discussion was held off the record.)
19	ADMINISTRATIVE LAW JUDGE REIF: Thank you,
20	again, Ms. Slawson, for providing these. The Commission
21	would like to have these included as part of the
22	transcript, if that's okay with you. I mean, typically,
23	you would be moving to do that.
24	MS. SLAWSON: Yes, we would move this to be
25	part of the transcript.



1	ADMINISTRATIVE LAW JUDGE REIF: Okay, very
2	good. Any objection?
3	MR. JETTER: No.
4	ADMINISTRATIVE LAW JUDGE REIF: Okay, they
5	are both admitted. And, Ms. Murray, thank you again for
6	being here this evening to help facilitate this hearing.
7	Are you aware of anyone who intends to speak this
8	evening?
9	MS. MURRAY: I am not.
10	ADMINISTRATIVE LAW JUDGE REIF: Okay.
11	Ms. Slawson, typically what we would do is we would wait
12	probably a few more minutes longer, just in case
13	somebody is trying to get parked and into the building.
14	But in the meantime, do you wish to call either
15	Ms. Gleave or Mr. Sanders, inasmuch as it is a public
16	witness hearing, and they are welcome to give comment or
17	testimony, if you would like them to do so.
18	MS. SLAWSON: We don't need to give
19	additional testimony at this time. We have handled it
20	earlier. That will be fine, thanks.
21	ADMINISTRATIVE LAW JUDGE REIF: Okay, all
22	right.
23	Mr. Jetter, if you don't mind me asking you,
24	please, are you aware of anyone who is going to be

appearing at this hearing?

1	MR. JETTER: No, we haven't received any
2	indication from anyone of an intent to appear.
3	ADMINISTRATIVE LAW JUDGE REIF: Okay. And I
4	realize that you are not testifying, but we will take
5	you proffer on this; are you aware of anybody who has
6	opposed this stipulation, and inasmuch as there's a rate
7	increase and decrease, as well as an increase in USF as
8	part of this docket?
9	MR. JETTER: No, I am not aware of any
10	opposition.
11	ADMINISTRATIVE LAW JUDGE REIF: Okay.
12	Ms. Murray, I realize that the Office isn't actively
13	involved with this docket, but, again, we really do
14	appreciate you being here to facilitate. And I may be
15	asking you the same thing I asked you before but in a
16	slightly different way; inasmuch as the Office interacts
17	with the public and with customers, in general, is the
18	Office aware of any opposition to the pending
19	application?
20	MS. MURRAY: We are not.
21	ADMINISTRATIVE LAW JUDGE REIF: Or the
22	pending stipulation?
23	MS. MURRAY: We have not received any
24	inquiries even asking about the matter, so we are not

aware of any opposition or anyone who plans to come.

2	appreciate that. And I also note that you are not under
3	oath but we will take that as a proffer, so thank you.
4	MS. MURRAY: Okay.
5	ADMINISTRATIVE LAW JUDGE REIF: We will be

9	ADMINISTRATIVE LAW JUDGE REIF: It is now
