Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7 of the Commission’s Rules, petitioner David R. Irvine (“petitioner”), hereby petitions for leave to intervene in this docket. In support of this petition, petitioner states as follows:

1. Petitioner is a resident of the state of Utah, and, like most other Utah residents, contributes to the federal Universal Service Fund, which includes the Lifeline program.

2. If TAG Mobile’s Lifeline-only Eligible Telecommunications Carrier application is approved by the Commission, TAG Mobile will be able to receive federal Lifeline subsidies for eligible residents of Utah who elect to receive lifeline service from TAG Mobile.

3. As a result, the legal rights and economic interests of petitioner, as well as the legal rights and economic interests of most Utah residents, will be substantially affected by this proceeding.

4. Petitioner seeks to intervene in this proceeding for the purpose of protecting his interests, as they may appear, as well as the interests of the residents of Utah who contribute to the federal Universal Service Fund and those who would be eligible to receive Lifeline service from TAG Mobile.

5. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing petitioner to intervene.
