**BACKGROUND**

On December 10, 2015, PlatinumTel Communications, LLC, d/b/a Care Wireless (Care Wireless) filed a petition for designation as an eligible telecommunications carrier for the limited purpose of offering lifeline service to qualified households.

On April 26, 2016, Care Wireless filed a motion to withdraw its petition, stating that the company has ceased all operations.

Neither the Utah Division of Public Utilities nor the Utah Office of Consumer Services objects to Care Wireless withdrawing its petition.<sup>1</sup>

**ORDER**

For good cause appearing, the Public Service Commission of Utah grants Care Wireless's motion to withdraw its petition for designation as an eligible telecommunications carrier. All deadlines of record are cancelled and vacated. The June 1, 2016 hearing is cancelled and vacated.
