To the Commission:

In accordance with Utah Code Annotated Section 54-7-12(7) and R746-405 and pursuant to the Public Service Commission's ("Commission's") Notice of Requirement to File a Petition to Amend Tariff or to Deviate from the Utah Affordable Base Rate issued April 18, 2016, Docket No. 16-R360-01 ("Commission's Notice"), the Supplemental Notice issued by the Commission on May 26, 2016, and the Order of the Commission issued June 7, 3026, South Central Utah Telephone Association, Inc. ("South Central") hereby makes this informational filing and modification to one of its tariff sheets filed on May 23, 2016. The original and 5 copies of the following are included with this Advice Letter:

1. The 7th Revised Sheet No. 22, canceling the 6th Revised Sheet No. 22 of South Central's Local Access Tariff on file with the Commission:

This revised tariff sheet modifies South Central's business rate and returns it to \$26.00 per month. As the Commission is aware, South Central increased its business rate to \$27.50 to comply with the Commission's proposed affordable base rate as issued on April 19, 2016. With the Commission's reversal of that rate in its Order issued June 7, 2016, South Central's Board of Directors has approved a reduction in the business rate back to \$26.00 to comply with the Commission's affordable base rate as now reflected the Commission's amendments to R746-360-6. South Central requests that the 7th Revised Tariff Sheet have an effective date of July 1, 2016.

Additionally, as required by the Commission's Supplemental Notice dated May 26, 2016, South Central confirms that the Tariff Sheets No. 22 accurately reflect the Residential and Business service rates, and that extended area service charges (if any), state subscriber lines

charges (if any), and State universal service surcharges will be in addition to South Central's residential and business rates. Thus, South Central's residential service (R1) rate and its business service (B1) rate, exclusive of mandatory extended area service, state subscriber line charges, and state USF surcharges, meet the affordable base rates of \$18 and \$26, as set by the Commission.

The tariff sheets as proposed do not constitute a violation of state law or Commission rule. South Central respectfully requests, in accordance with R746-405-2(E)(3), that the Commission waive the 30 day notice period and that the 7th Revised Tariff Sheet No. 22 become effective July 1, 2016 as contemplated in the Commission's Notices and Order in Docket 16-R360-01.
