This filing establishes a new service offering called Ethernet Switched Access Local Transport (ESALT). ESALT enables the customer to handoff Internet Protocol (IP) traffic to SCUTA. This is offered as another direct trunk option. This option allows SCUTA to convert traffic from Time Division Multiplexing (TDM) to IP format which many FGD carriers prefer.

1st Revised Sheet No. 87.4, Section 6.2. (A) (4) was cleaned up to remove text that pertains to entrance facility, which is not used by SCUTA. 4th Revised Sheet No, 230.1 we clarified that the state rates and/or charges for intrastate terminating traffic mirror the interstate terminating rates.

This filing also references the authorized Interstate Access Tariff 5 in lieu of rates for ESALT.

It is requested that this filing become effective August 9, 2016.
