BACKGROUND

On April 21, 2000, in Docket No. 99-2299-01, the Public Service Commission of Utah (PSC) granted Integra Telecom of Utah, Inc. (Integra) a Certificate of Public Convenience and Necessity (CPCN), authorizing the company to provide public telecommunications services within the State of Utah.<sup>1</sup>

On October 28, 2016, Integra notified the Commission that, effective August of 2016, it began operating under the name Electric Lightwave Holdings, Inc.<sup>2</sup>

Both the PSC and the Division of Public Utilities (Division) understood Integra's notice to be a request for acknowledgement of the new name and for amendment of the CPCN.

Therefore, the PSC noticed a 30-day comment period and, on October 31, 2016, the Division filed a memorandum recommending that the Commission acknowledge the new name.

On November 22, 2016, the PSC issued an order acknowledging the new name and amending the CPCN accordingly. On November 29, 2016, Integra requested review of the order, explaining that its October 28, 2016 notice was submitted as information only. The notice was intended for the sole purpose of informing the PSC that future payments of regulatory fees would be tendered under the name Electric Lightwave Holdings, Inc. Integra has not changed the name of any entity operating in Utah and does not require its CPCN to be amended.

ORDER

Given the foregoing, the Public Service Commission of Utah vacates the order issued November 22, 2016 in the above-captioned dockets.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
