RE: Docket No. 16-2303-T01 Hanksville Telephone, Inc. filing to revise

Residential R1 and Business B1 rates to comply with current

Commission proposed Affordable Base Rate rules.

## **ISSUE:**

Hanksville Telephone, Inc. (Hanksville) is filing revisions to its Exchange Services Tariff PSC Utah No. 1, that with the addition of mandatory EAS (Extended Area Service) charges and State USF (Universal Service Fund) surcharges, will add up to meet the current Commission proposed Affordable Base Rate rules.

Hanksville has proposed a rate increase for the Basic Residential (R-1) Service from \$11.03 per month to \$17.82 per month as follows:

Exchange	Current Residential Rate	New Residential Rate
All Exchanges	\$11.03 <sup>1</sup>	\$17.82

The rate increases are necessitated by the Commission's proposed Affordable Base Rate which requires Emery to charge a floor of \$18.00 per month for residential service and \$26.00 per month for business service in order to remain eligible for State USF support. Pursuant to the Commission's Supplemental Notice, telecommunications providers are permitted, but not required, to include mandatory extended area service ("EAS") charges, State subscriber line charges (if any), and state universal service fund surcharges ("State USF") in determining whether such carrier's rates meet the Commission proposed Affordable Base Rate. Hanksville's revised residential rates will not be inclusive of the mandatory EAS, State USF surcharges, and State SLCs. Rather, such rate elements will remain separate. However, the sum of the

Residential (R-1) rate, the mandatory EAS, the State USF Surcharge, and the State SLCs is equal to the Commission proposed Affordable Base Rate of \$18.00 for residential service as follows:

Mandatory EAS	n/a
State SLC	n/a
State USF	\$0.18
Total:	\$18.00

Hanksville is requesting an increase to its Business rate B-1 as follows:

Exchange	Current Business Rate	New Business Rate
All Exchanges	\$19.37 <sup>2</sup>	\$25.74

The revised business rate will not be inclusive of the mandatory EAS, State USF surcharges, and State SLC. Rather, such rate elements will remain separate. However, the sum of the Business (B-1) rate, the mandatory EAS, the State USF Surcharge, and the State SLCs is equal to the Commission proposed Affordable Base Rate of \$26.00 for business service:

## **RECOMMENDATION: Approve New Tariff Changes**

The above basic rate modifications are pursuant to the Public Service Commission's Notice of Requirement to File a Petition to Amend Tariff or to Deviate from the Utah Affordable Base Rate Notice, issued April 18, 2016, Docket No. 16-R360-01

Since the requested residential rate increase complies with the requirements in the Commission's Notice, the Division recommends that the Commission **approve** the new updated tariff sheets for Hanksville in Docket No. 16-2303-T01 and that the **Commission waive the 30 day notice period** and that the tariff becomes effective July 1, 2016 as contemplated in the Commission's Notices and Order in Docket 16-R360-01.
