This filing is made in compliance with the Federal Communication Commission's (FCC) 2016 Lifeline Modernization Order for the adopted rules effective December 2, 2016 in Title 47: Telecommunication; Part 54- Universal Service. The eligibility requirements section was updated to reference those adopted sections. Additionally, this filing also removes references to Tribal Lifeline since Direct Communications Cedar Valley, LLC does not have any tribal land, and updates the Lifeline Service section to reflect the \$9.25 federal credit instead of the dated Tier method. The \$9.25 was implemented when that became effective so this is not a change to the lifeline customer.

It is requested that this filing become effective December 2, 2016.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with other Tariff sections. This filing is revenue neutral.
