1. INTRODUCTION

XYN Communications of Utah, LLC ("XYN" or "Applicant"), pursuant to Utah R749-349 hereby respectfully submits to the Utah Public Service Commission (the "Commission") an application for authority to offer facilities-based, resold local and access telecommunications services in the non-rural wire centers in the State of Utah. XYN seeks a Certificate of Public Convenience and Necessity ("CPCN") to provide these services in the Proposed Service Area. XYN intends to provide residential and business retail and wholesale telecommunications and access services using its own network infrastructure as well as those of their underlying carrier(s).

II. GENERAL COMPANY INFORMATION

In support of this Application for authority to provide local exchange telecommunications in the Proposed Service Area, XYN states the following:

XYN is a Utah domestic limited liability company with its principal place of business located at 8275 S. Eastern Avenue, Suite 200, Las Vegas, NV 89123. III. FINANCIAL AND TECHNICAL QUALIFICATIONS

XYN possesses the technical, managerial and financial resources to provide competitive local exchange telecommunications to serve the public interest, by giving Utah customers more choices in selecting their telecommunications service provider. Attached as Exhibit B is a Public

Copy of the financial statements of XYN's parent company, XYN Holdings, Inc. A confidential version of this Exhibit has been provided under seal inside a separate sealed envelope. Treatment. Attached as Exhibit C are projected financials. Also enclosed are the resumes of management and key personnel as Exhibit D. XYN is applying for facilities-based local exchange services in the following states: Arizona, Colorado, South Dakota, Nebraska, Oklahoma and Nevada.

IV. DEPOSITS AND BONDS

XYN does not intend to collect deposits from its retail customers. XYN may require a deposit from a wholesale carrier customer. XYN respectfully requests a waiver from R746-349-3(2) requiring a bond of \$100,000 as it will not collect deposits from retail customers. In the event the company intends to begin collecting deposits, a bond will be obtained and submitted to the Commission.

V. FACILITIES

XYN will use a combination of its own facilities and those of other carriers to provision its service. The type and location of facilities in Utah will be determined at a later date depending on the number of customers in Utah.

VI. SERVICE AREA AND TYPE OF SERVICE

XYN is requesting the service area currently being served by CenturyLink/Qwest. XYN does not intend to provide services in any area considered rural or within an area of an incumbent with less than 30,000 lines.

XYN business plan includes telecommunications service to primarily business customers in non-rural areas. XYN intends to market services to the general public.

In accordance with R746-349-3(5) XYN intends to provide directory assistance, directory listings and emergency 911 and E911 service either directly or through their underlying carrier(s).

XYN will begin the process of obtaining numbering resources within the State of Utah

once this Application is approved by the Commission.

VII. COMPLAINTS AND POLICIES

XYN currently has no complaints nor are they under investigation for unauthorized

switching (slamming) or other illegal activities. XYN has never been sanctioned for any of these

activities.

XYN has a written Letter of Agency which is used to solicit new customers.

VIII. CONCLUSION

XYN possesses the technical and managerial ability and the necessary financial resources

to provide competitive local exchange telecommunications services that will serve the public

interest by providing Utah customers with additional options in choosing their telecommunications

service provider.

WHEREFORE, XYN respectfully requests that the Commission issue an Order approving

this Application by issuing a Certificate of Public Convenience and Necessity provide local

exchange telecommunications services in the Proposed Area.
