JSI files the enclosed tariff material on behalf of Bear Lake Communications, Inc. (Bear Lake). This tariff filing establishes a new Bear Lake Intrastate Access Tariff PSC Utah No. 2 and supersedes and cancels the Central Utah Telephone, Inc. and Subsidiaries PSC Utah No. 2 effective September 20, 2018. This filing is made pursuant to the request of the Utah Public Service Commission that Central Utah and Subsidiaries (Central Utah Telephone, Inc., Bear Lake Communications, Inc. and Skyline Telecom) file their respective tariffs independently going forward instead of one consolidated tariff. This filing provides for establishment of a separate tariff for Bear Lake Communications, Inc.

The terms and conditions of the proposed Bear Lake Tariff PSC No. 2 mirror page for page those of the consolidated tariff which it will supersede. The sole change is that Section 17 Rates and Charges in the new tariff are limited to currently effective rates and charges of Bear Lake. No revisions are proposed to currently effective rates and charges.
