### Re: MCImetro Access Transmission Services Corp.'s Request for Numbering Waiver

Dear Mr. Widerburg:

MCImetro Access Transmission Services Corp. d/b/a Verizon Access

Transmission Services ("MCImetro") respectfully requests a waiver to obtain the

contiguous numbering resources required to meet a specific customer request at a

location served by the SLKCUT24DS1 switch within the Clearfield rate center. If

granted, the waiver will allow the Pooling Administrator ("PA")/Neustar, the Number

Pool Administrator, to provide three contiguous thousand number blocks in the 801

NPA to be assigned to the SLKCUT24DS1 switch within the Clearfield rate center in order to meet this specific customer request.

In a confidential letter (**Confidential Attachment A** hereto), the customer is requesting 3,000 contiguous numbers in the 801 NPA in any NXX in the range of XXX-7000 to XXX-9999. The customer's request for the contiguous numbers results from the need to align with the customer's existing private dialing plan, and to accommodate the customer's migration to a new communications platform.

According to FCC requirements (47 C.F.R. § 52.15(g)), to qualify for additional numbering resources, a service provider must submit paperwork demonstrating that the rate center for which the numbers are requested is at, or at less than, six Months-to-Exhaust ("MTE") and at 75% or more utilization. In cases where a service provider is not able to meet a specific customer request with available inventory, the FCC has determined that state utility commissions have jurisdiction to grant a waiver pursuant to FCC 01-362 (December 28, 2001), Section IV, ¶¶ 57-66. In ¶ 66 thereof, the FCC recommends that the state utility commission respond within 10 business days of a waiver request.

To satisfy the customer request, MCImetro submitted a request for numbers and supporting documents to the PA/Neustar (**Attachment B**<sup>2</sup> and **Confidential Attachment C**<sup>3</sup> hereto). The PA/Neustar denied the request on April 20, 2018 because MCImetro does not meet the utilization and MTE requirements (**Attachment D** hereto). In order for the request to be approved, MCImetro needs a waiver approval by the Utah Public Service Commission ("UT PSC") to override the PA/Neustar's denial of requested numbering resources.

MCImetro respectfully requests that the UT PSC approve this request for waiver and direct the PA/Neustar to make the necessary assignment of numbering resources so that MCImetro can meet its customer's request – specifically, by directing the PA/Neustar to provide three contiguous thousand number blocks in the 801 NPA that can accommodate the range of XXX-7000 to XXX-9999, to be assigned to the SLKCUT24DS1 switch within the Clearfield rate center.

#### Instructions for filling out each Section of the Part 1A form:

Section 1.1 Contact information requires that Service Providers supply under "Block Applicant" the company name, company headquarters address, a contact within the company, an address where the contact person may be reached, in addition to the correct phone, fax, and e-mail address. The Pooling Administrator section also requires the Service Provider to fill in the Pooling Administrator's name, address, phone, fax and e-mail.

Section 1.2 Service Providers who need a thousands-block assignment or for an Location Routing Number (LRN) are required to fill in this section. If needed for an LRN, a CO Code Application needs to also be submitted to the PA. The Service Provider should supply the Numbering Plan Area (NPA); the Local Access Transport Area (LATA), which is a three-digit number that can be found in the Telcordía Technologies, Inc. dba iconectiv (iconectiv<sup>TM</sup>) LERG<sup>TM</sup> Routing Guide<sup>xi</sup>. The Operating Company Number (OCN) assigned to

the service provider and the OCN of its parent company.
