In accordance with their July 15, 2019 filing, SRR Partners, LLC d/b/a Sorrel River Ranch Resort & Spa (“SRR”) hereby informs the Public Service Commission of Utah (“Commission”) that they have been unable to settle this case with Frontier Communications.

In its May 24, 2019 Order, the Commission invited SRR to consolidate this proceeding with the investigative docket, Docket No. 19-041-04. At that time, SRR believed it would be better and more efficient to keep these two dockets separate.
