In accordance with R746-405 of the Public Service Commission's Rules, South Central Utah Telephone Association, Inc. As a result of the communications with the Division of Public Utilities, 1st Revised Sheet No. 20 and 10th Revised Sheet No. 22 were corrected for an oversight. 2nd Revised Sheet No. 23 was added to this filing due to the revision on 10th Revised Sheet No. 22. These changes are as follows:

 1st Revised Sheet 20, added the current late payment charge of 1.5%, the \$20 returned check charge, and \$0 charge for the declined credit card and automated clearing house returned or declined payment charge. SCUTA will follow Utah Code 54-7-12, Section 7, for future changes and those changes would be filed with the Public Service Commission of Utah.



- 2. 10th Revised Sheet No. 22, had a change submitted by Kira Slawson on May 8, 2019, which added the Extended Service Areas rates by exchange area prefixes that have been in place since SCUTA acquired the rural local exchanges from US West/Qwest in 1994 and 1998, and this change incorporated the rates that were inherited from US West/Qwest that have been in place since that time.
- 3. 2nd Revised Sheet No. 23, was also submitted by Kira on May 8, 2019. This tariff sheet deleted the EAS Calling Service section since it is now covered on 10th Revised Sheet No. 22 with more detail. This tariff sheet was not originally filed on April 15, 2019, but included with this filing.
- 4. Overall this filing also proposed to:
 - a. Eliminate obsolete services or those services no longer needed because there were no customers,
 - b. Revise outdated text; which did not interfere with services or rates,
 - c. Change the original proposed effective date from May 14, 2019 to May 31, 2019, and
 - d. Add two new services to the Local Tariff for Direct Inward Dialing Service (DID) and Integrated Service Digital Network (ISDN).

The Certificate of Service for this Amendment is also included.

We request that this proposed filing become effective May 31, 2019.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with other Tariff sections. The tariff sheets do not constitute a violation of state law or Commission rule.
