**Re: Advice Letter No. 35; Revisions to Price List No. 3**

Dear Commissioners:

Enclosed for filing with the Utah Public Service Commission is an electronic copy of this Advice Letter No. 35 and revised price list sheets for the Utah Price List No. 3 of Electric Lightwave, LLC dba Allstream (f/k/a Integra Telecom of Utah, Inc.).<sup>1</sup> The following list of revised tariff sheets includes a description of the proposed changes:

- 1<sup>st</sup> Revised Title Sheet – Updated name; deleted obsolete language
- 22<sup>nd</sup> Revised Sheet No. 2 – Revised Check Sheet
- 1<sup>st</sup> Revised Sheet Nos. 8 & 54 – Updated name and contact information
- 10<sup>th</sup> Revised Sheet No. 72 – Added Month-to-Month rate; increased monthly recurring charge for On-Net Basic Business Lines
- Updated throughout to reflect the name “Electric Lightwave, LLC dba Allstream”

This rate increase will only impact out-of-contract (i.e., month-to-month) customers, and increases to 1-Yr, 2-Yr, and 3-Yr term rates will only impact new customers. Customers impacted by this increase have been provided 30 days’ notice via bill message during the October bill cycle:

**NOTICE OF PRICE INCREASE – COLORADO, NORTH DAKOTA, UTAH**

According to our records your initial contract term has completed. If applicable, effective with the November billing cycle you will see a price increase of \$2/line on Basic Business Lines.
