On August 9, 2019, Fusion Connect, Inc., Fusion Cloud Services, LLC, and Telecom Holding LLC filed with the Public Service Commission (PSC) a joint application for approval to transfer indirect ownership and control of Fusion Cloud Services, LLC to Telecom Holdings LLC.

Any interested party may submit comments on the joint application no later than **Monday, August 26, 2019** and reply comments no later than **Tuesday, September 3, 2019**. If no comment is filed in opposition to the proposed transfer of control by the initial comment date of August 26, 2019, the PSC will adjudicate this docket informally and without hearing. If any objection is made to the joint application, the PSC will hold a hearing on **Tuesday, September 10, 2019, at 10:00 a.m.** to consider the joint application and the objection(s).

The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.**
