Dear Ms. Paschal:

As detailed in AT&T Corp.'s ("AT&T" or "Company") Application filed July 1, 2020, AT&T is discontinuing providing residential local exchange service in Utah effective September 30, 2020. Residential customers were notified by first-class mail and by bill statement messages of the discontinuance of this service and of alternate service options with other providers.

In association with the discontinuance, the Company is cancelling and withdrawing the AT&T Corp. Local Residential Exchange Service Tariff in its entirety. The AT&T Corp. Telecommunications Services Tariff is also being updated to remove references to any "bundled" offerings which included both residential local exchange service and long distance as part of one plan. The Telecommunications Services Tariff will continue to reflect AT&T's residential standalone long-distance product offers.

Attached is a list of pages being withdrawn and the title page cancelling and withdrawing the AT&T Local Residential Services Tariff in its entirety. The Company respectfully requests that the proposed changes become effective on September 30, 2020.
