Re: Notification Regarding the Change In Name of TeleQuality Communications,

LLC to ENA Healthcare Services, LLC

Dear Sir or Madam:

By this letter, Education Networks of America, Inc. ("ENA") notifies the Commission of the change in name of "TeleQuality Communications, LLC" to "ENA Healthcare Services, LLC", which became effective in Utah on February 18, 2020. A certified copy of the Amendment filed with the State of Utah Department of Commerce is enclosed for reference.

By Order issued December 7, 2017, the PSC approved the transfer of indirect control of TeleQuality Communications, Inc. from its parent company, TQCI Holdco, Inc. to ENA. On January 2, 2018, ENA purchased TeleQuality Communications, Inc.("TeleQuality"), making it a wholly-owned subsidiary of ENA. As part of the transaction, TeleQuality became a limited liability company based in Delaware.

TeleQuality, through new management, deployed the following campaign to notify customers that the name of the company was going to change: First, account managers for the Company called customers and let them know the name of the company was changing as a part of normal communications. Second, the marketing team updated and re-directed the company website to the new "name" and brand for the company. Third, all marketing collateral and other normal notices forward to the new company website and phone numbers. There is commercially reasonable notice in all normal channels and all contact information for the previous company redirects in a cohesive manner such that customers are aware of the name change and able to contact the company in ordinary course.
