STIPULATED SETTLEMENT AGREEMENT AND MOTION TO AMEND SCHEDULE

Pursuant to Utah Code §54-4a and Admin. Code r.746-1, the Division of Public Utilities ("Division") files this Stipulated Settlement Agreement and Motion to Amend Schedule. The Division, Utah Office of Consumer Services ("Office") and Uintah Basin Electronic Telecommunications, L.L.C. ("UBET" or the "Company") collectively ("Parties") have entered into a settlement stipulation and seek approval by the Public Service Commission of Utah ("Commission"). The Parties also request that the remaining schedule be vacated and an amended hearing date be set for September 22, 2020.

On June 10, 2020 UBET filed a Petition seeking designation as an Eligible

Telecommunications Carrier in the state of Utah for the purpose of offering wireless Lifeline service and to participate in the Utah Universal Service Fund for Lifeline purposes. The

Commission filed an Action Request on June 10, 2020 to the Division and subsequently noticed

a telephonic scheduling conference. A telephonic scheduling conference was held on June 18,

2020. The Parties agreed to a schedule and a Scheduling Order and Notice of Hearing was issued

by the Commission on June 18, 2020. UBET filed Direct Testimony of Karl Searle on July 13,

2020.

The Parties have engaged in good faith negotiations and have reached a settlement

agreement attached to this filing. The Division requests that the Commission vacate the

remaining filing deadlines set in the June 18, 2020 Scheduling Order and set an amended hearing

date on September 22, 2020 if that date is available.

The Division has provided a copy of this Motion to the Office and UBET and has been

authorized to represent that each of the parties support this motion. The Division is not aware of

any opposition to the Motion.
