Pursuant to Utah Code §54-4a and Admin. Code r.746-1, the Division of Public Utilities (“Division”) files this Motion for Extension of Time to File Action Request Response and Amend Schedule. The Division respectfully requests that the Commission extend the deadline for the Division to file its action request response and the corresponding date for interested party comments to Thursday, October 29, 2020 and the date for reply comments to Friday, November 13, 2020.

Arcadian Infracom 1, LLC filed its application for a CPCN on September 22, 2020. Public Service Commission of Utah (“Commission”) issued an Action Request on September 22, 2020 and a subsequent Supplemental Action Request on the same day. On September 23, 2020 the Commission issued a Notice of Filing and Comment Period setting dates for interested party

comments and reply comments for October 22 and November 6 respectively. The Division has been in discussions with the Applicant regarding the proposed service offerings and is requesting an extension of time before filing its action request response. It is reasonable to also extend the comment and reply comment filing dates as a result. For this reason, the Division requests an extension for its filing date and interested party comments to Thursday, October 29, 2020 and for reply comments to Friday, November 13, 2020.
