Pursuant to Utah Admin. Code r.746-1, the Division of Public Utilities (“Division”) files this Settlement Stipulation and Motion to Amend Schedule. The Division submits the attached Stipulation and Settlement Agreement and requests that the Public Service Commission (“Commission”) vacate the remaining testimony dates and amend the schedule hearing date for April 12, 2021 at 1PM.

The Commission set a schedule for this docket in its January 20, 2021 Scheduling Order. No intervenors filed for intervention prior to the March 1, 2021 deadline.
