ISSUED: April 6, 2021

On April 5, 2021, the Division of Public Utilities (DPU) filed a Settlement Stipulation and Motion to Amend Schedule in this docket. DPU asks the Public Service Commission (PSC) to vacate the remaining testimony filing deadlines as well as the scheduled hearing on the merits, and schedule a new hearing April 12, 2021 to hear evidence and argument on the Settlement Stipulation.

The PSC appreciates the parties' efforts to reach the Settlement Stipulation and believes it is in the public interest to consider those terms in a timely fashion. Therefore, the PSC grants the request for a hearing on April 12, 2021 to consider the Settlement Stipulation, and vacates all remaining testimony filing deadlines in this docket.
