





Business Anytime II is a flat rated Dial-1 service. All calls are billed in whole minute increments. Partial minutes are rounded up to the next whole minute.

#### 104.6.2 BUSINESS COMPLETE BLOCK OF TIME

#### A. Description

Business Complete Block of Time offers small business customers a block of minutes for a flat monthly fee. The blocks of minutes can be used for Dial-1 long distance and toll free voice services in the interstate and intrastate jurisdictions. Block minutes cannot be applied to Operator Services calls. No international usage can be applied to the block minutes.

#### B. Description

- 1. Customers may subscribe to only one block of minutes for their monthly long distance usage.
- 2. Qualified domestic Dial-1 outbound and toll free service usage will contribute towards Block minutes as such qualified calls are completed. The Company will charge Customers for any usage in excess of the block minutes (overage minutes) selected at the rates set forth herein. Block minutes that have not been used at the end of the Customer's billing cycle will not carry over to the next month.
- 3. Minutes used in excess of the Customer's selected Block of Time will be billed in whole minute increments. Partial minutes are rounded up to the next whole minute.
- 4. Multiple lines subscribe to a single Block of Time option must be billed under the same account, whether or not at the same location. The monthly recurring charge applies per account.

#### C. Rates and Charges

The following per minute rates apply for qualified interstate and intrastate Dial-1 and Toll Free Service minutes above the customer's monthly block of time:
