On August 30, 2021, Mobilitie Management, LLC ("Mobilitie") filed a request with the Public Service Commission (PSC), seeking to cancel its Certificate of Public Convenience and Necessity ("CPCN") and withdraw its tariffs.

The Division of Public Utilities (DPU) filed comments on September 1, 2021. DPU states that notice to Mobilitie customers is not required because Mobilitie has no Utah customers and does not plan to offer telecommunications service in the future. DPU also states that Mobilitie has complied with Utah Admin. Code R746-350-1, et seq., and therefore recommends approval of the cancelation of its CPCN.

Based on the PSC's review of Mobilitie's request and DPU's recommendation, and since no opposition to the request was filed, the PSC finds cancelation of Mobilitie's CPCN is in the public interest. Accordingly, Mobilitie's CPCN, issued on May 27, 2016 in Docket No. 16-2589-01, is canceled, effective the date of this order.

Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
