- (b) On 2/22/21 Another Teck named Steve came checked phone lines, the day was fair and the Static left.
- (c) On 2/24/21 Called CenturyLink Spoke to Jenene she checked history; said she will credit our account \$75.96. Con. # 17971264 also Con. # C22038711-11, also spoke with the Loyalty Dept.
- (d) On 3/8/21 CenturyLink Adjusted Feb payment from \$97.35 to \$14.70 due to phone Static. Bill 2/25/21.
- (e) On 5/2/21 Spoke to Debbie @ Century said The Teck repaired phone line on 4/27/21. Bill Date 4/25/21.
 Mark A. Reid, Area Super (801-391-5351) had Telecom Contractor name Jacinto (385-519-9973) put in new line. Bill date 4/25/21.
- (f) In July 2021 the phone still had STATIC PROBLEMS and customer service give us a \$28.66 credit on the August 25 billing for \$28.66.
- (g) On 12/9/22, I contacted Kelley with the problem she gives me a Confirmation #034058057 for a Teck. Who Never shows up. On 12/14/22 I contact Becky, she gives me Confirmation # 0361442, for Teck, He comes

- I show him pictures of a Pedestal leaning at a 30-to-40-degree angle with phone lines exposed to the weather, located in my back yard neighbors S.E. corner of the lot. The Teck said he will have the Pedestal replaced. (Bill date 11/25/22.)
- (h) TO THIS VERY DAY (12/29/22) we have STATIC PROBLEMS. I have enclosed a copy of history dated EMAIL CONTACTS with CENTURYLINK TO SOLVE THIS PROBLEM. I believe CENTURYLINK does not want to service LAND PHONES because they are old worn systems and are waiting for CenturyLink NEW FIBER OPTICS to come, so they simply Band-Aid the problems on land phones. I think this is wrong, unjust and improper for CenturyLink paying customers who DESERVE GOOD SERVICE. It should not be a problem to solve a STATIC PROBLEM when it rains, or snows and the water Gets into the system. and if the equipment is worn out, they should replace it for the customers who prefer Land phones. The advantage of having land phones is when power fails, the Land phone still works.

FIX THE LAND PHONE SO IT IS NOT PLAGUED WITH STATIC PROBLEMS AND WORKS PROPERLY.
