BACKGROUND

On July 5, 2022, McLeodUSA Telecommunications Services, LLC d/b/a PAETEC Business Services notified ("Notification") the Public Service Commission (PSC) of its name change to McLeodUSA Telecommunications Services, LLC ("McLeodUSA"). McLeodUSA holds a Certificate of Public Convenience and Necessity ("CPCN") to provide public telecommunications services in Utah, originally granted to McLeodUSA Telecommunications Services, Inc., pursuant to the PSC's May 19, 1998 order in Docket No. 98-2249-01.

On July 14, 2022, the Division of Public Utilities (DPU) filed comments recommending the PSC acknowledge the name change and requesting the docket be adjudicated informally. DPU states that the name change will not impact any customers in Utah, nor result in any changes to the services that McLeodUSA offers to its Utah customers.

ORDER

The Notification shows McLeodUSA updated its new name and regulatory contact information with DPU. DPU's comments confirm no customers in Utah will be adversely affected. Based on the PSC's review of the Notification and DPU's comments and recommendation, the PSC acknowledges McLeodUSA's name change and amends

McLeodUSA's CPCN to reflect its new business name. The amended CPCN is attached as Exhibit A.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
