Please accept this letter submitted on behalf of Matrix Telecom, LLC d/b/a Matrix Technologies d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Startec d/b/a Lingo ("Company") to notify the Utah Public Service Commission ("UT PSC") that the Company is changing its corporate name to Lingo Telecom, LLC d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Startec d/b/a Lingo. The Company is also canceling the d/b/a Matrix Business Technologies. The company received approval to provide resold and facilities-based local exchange and resold intrastate interexchange telecommunications services in Utah in Docket No. 05-2451-01.

The Company respectfully requests the UT PSC to change the Company's corporate name in all Commission records to Lingo Telecom, LLC d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Startec d/b/a Lingo and allow the replacement tariffs to go into effect on April 18, 2022.
