BACKGROUND

On April 8, 2022, Matrix Telecom, LLC (“Matrix”) d/b/a Matrix Technologies d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Startec d/b/a Lingo, notified the Public Service Commission (PSC) that it is changing its name to Lingo Telecom, LLC (“Lingo”) d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Startec d/b/a Lingo (“Notification”). The Notification also states Lingo is canceling the d/b/a Matrix Business Technologies. Lingo currently offers interexchange and local services in Utah. Lingo also filed updated price lists reflecting the new name as exhibits to its filing.¹ Lingo explains that no changes to any customers’ services will occur as a result of the name change.²

Lingo holds a Certificate of Public Convenience and Necessity (“CPCN”) to provide competitive local exchange service in Utah (originally granted to the predecessor company Matrix) pursuant to the PSC’s December 15, 2005 order in Docket No. 05-2452-01. In

¹ Competitive local exchange carriers do not file tariffs in Utah, rather they file price lists in accordance with Utah Code Ann. § 54-8b-2.3. Price lists become effective five days after filing unless the PSC takes action to suspend them.

subsequent related dockets Matrix has submitted name changes and business reorganizations for PSC approval or acknowledgment.

On April 11, 2022, the Division of Public Utilities (DPU) filed comments recommending the PSC acknowledge the name change and the updated price lists.

ORDER

The Notification shows Lingo registered its new name with the Utah Division of Corporations and Commercial Code, and that its name change will not result in any changes to the services that Lingo offers to customers in Utah. Based on those details, the PSC's review of DPU's comments, and DPU's recommendation, the PSC acknowledges Lingo's name change and amends Lingo's CPCN to reflect its new business name. The amended Certificate of Public Convenience and Necessity is attached as Exhibit A.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
