## Recommendation (Acknowledge)

The Division of Public Utilities (“Division”) recommends that the Public Service Commission (“Commission”) acknowledge the receipt of this Amended Interconnection Agreement.

## Discussion

On or about November 22, 2023, Qwest Corporation d/b/a CenturyLink QC (“CenturyLink”) filed the Resale Forbearance Amended Interconnection Agreement per the above-referenced docket in accordance with § 54-8b-2.2(1) (d) of the *Utah Code*. This Agreement had been fully executed through voluntary negotiations on May 23, 2022, and amended on November 22, 2023, with Preferred Long Distance, Inc. (“Preferred”).

The Division has reviewed the above-mentioned Agreement between CenturyLink and Preferred and sees no reason to reject it. Specifically, the Division believes that the Agreement was negotiated in good faith and without unfair discrimination. Both parties also recognize that, to the extent that the existing rules are changed, vacated, dismissed,
