Re: Advice Letter—UBTA-UBET Communications Inc. /Tariff Filing

To the Commission:

In accordance with R746-405 of the Public Service Commission's Rules, UBTA-UBET Communications Inc. ("UBTA-UBET") hereby electronically files the attached Sheets from the UBTA-UBET Communications Inc. Local Tariff P.S.C. Utah No. 1, together with the redlines showing the changes made:

1. 3rd Revised Sheet No. 2, canceling 2nd Revised Sheet No. 2 – modified Section Index (note the Redline doesn't accurately show the page numbers in the Index due to automatic generation).
2. 3rd Revised Sheet No. 3, canceling 2nd Revised Sheet No. 3 – modified Section Index (note the Index table spacing was modified to fit on one page) so Sheet 3 is now "Reserved".
3. 2nd Revised Sheet No. 5, canceling 1st Revised Sheet No. 5 – modified to eliminate Extension Station (Off Premise Extension) since this service is no longer available.
4. 2nd Revised Sheet No. 6, canceling 1st Revised Sheet No. 6 – modified to eliminate reference to Off Premise station service which is no longer available.
5. 4th Revised Sheet No. 20, canceling 3rd Revised Sheet No. 20 – modified to reduce B1 and PBX Outward Rates by \$1.00 due to the FCC required increase in Access Recovery Charge (ARC) on multiline businesses that will be effective

July 1, 2023.¹ This change will not result in any change in rates to the customer since the \$1.00 increase in ARC will offset this \$1.00 reduction.

6. 2nd Revised Sheet No. 25, canceling 1st Revised Sheet No. 25 – modified to eliminate the Off-Premise Extension Service which is no longer available.

UBTA-UBET Communications Inc. hereby files its tariff revisions reflecting these corrections. The Tariff sheets, as proposed, do not constitute a violation of State law or Commission rule. UBTA-UBET Communications Inc. respectfully requests that the Commission accept the Revised Tariff sheets with the proposed effective date of July 1, 2023.
