II. IDENTITY OF PETITIONER

AT&T and TCG are telecommunications companies authorized to provide local exchange, intraexchange, and interexchange telecommunications services throughout Utah including the 801 Numbering Plan Area ("NPA"), and have been assigned number blocks within the 801 NPA. AT&T also provides wireless service.

III. INTEREST OF PETITIONER

As local exchange service providers in the greater Salt Lake City area, AT&T and TCG rely on number resources being available. In addition, AT&T also relies on the availability of number resources as a wireless service provider. Any number shortage as well as the means to relieve the shortage in both the short and long run will directly affect AT&T and TCG and their ability to provide telecommunications services. Accordingly, AT&T and TCG have a direct and substantial interest in ensuring the efficient, nondiscriminatory, and competitively neutral availability and use of telephone number resources in the greater Salt Lake City area.

IV. NATURE OF INTERVENTION

The evidence to be presented by AT&T and TCG, if any, will be of material value to the Commission in its determination of the issues involved in this proceeding, and AT&T and TCG's interventions will not broaden those issues or delay the proceedings.
