

1. U S WEST is an incumbent telephone corporation under Utah Code Ann. § 54-8b-2(4) and is a public utility authorized to provide public telecommunications services in various parts of the state of Utah pursuant to Certificate of Convenience and Necessity No. 1499 issued by this Commission.

2. On or about December 13, 1999, the Division of Public Utilities (“Division”) filed a Petition requesting the establishment of a docket to consider the request of the North American Numbering Plan Administrator (“NANPA”) for 801 area code relief. The Commission issued an Order establishing Docket No. 99-999-05 which was consolidated with Docket No. 99-999-04, a previously created docket to consider number conservation measures.

3. U S WEST and its customer’s interests will be substantially affected by the proceedings in this docket. In addition, U S WEST can provide valuable input to the Commission in this docket.

4. Granting U S WEST intervention will not impair the interests of justice nor the orderly and prompt conduct of the proceedings. U S WEST participated in the Pre-Hearing Conference held on December 21, 1999 and in the Technical Conference held on January 7, 2000. U S WEST intends to continue to participate to the full extent permitted under the Commission’s rules and Utah law. To the extent that the Commission has scheduled further proceedings in this docket, U S WEST agrees to comply with the schedule as established by the Commission.
