SYNOPSIS

Supra Telecommunications & Information Systems, Inc. having requested that its certificate of public convenience and necessity be canceled, the Commission so orders.

PROCEDURAL HISTORY

On May 19, 1998, Supra Telecommunications & Information Systems, Inc. (Supra) filed an application for authority to provide local exchange telecommunications services within the State of Utah to the extent permitted by law. The application was given Docket No. 98-2253-01. The case was converted into an informal proceeding and there was no hearing held. The Commission granted Certificate of Public Convenience and Necessity No. 2253 on January 15, 1999. The Company was authorized "... to provide local and interexchange services and other public telecommunications services anywhere within the State of Utah, ... except within any local exchange carrier with fewer than 5,000 access lines that is owned or controlled by an incumbent telephone company with fewer than 30,000 access lines within the State."

By letter dated September 10, 2003, Supra requested cancellation of its certificate in Utah. The letter from the Company's Administrative Assistant, Regulatory states that the Company no longer desires to do business in the State of Utah and requests to withdraw its license. The letter further states that the Company did not operate under its license and has no outstanding obligations.

The Commission has received a memorandum from the Utah Division of Public Utilities (Division) with a copy of the letter attached to the memorandum. The Division states that it is their understanding that the Company does not now, and never has provided any service in the State of Utah. Therefore, the termination of the Company's authority will have no adverse impact upon any customers in the State of Utah. The Division therefore recommends that the Commission cancel the certificate of public convenience and necessity held by Supra Telecommunications & Information Systems, Inc.

<u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that:

Certificate of Public Convenience and Necessity No. 2253 held by Supra Telecommunications & Information Systems, Inc., be and hereby is canceled.
