On May 11, 2005, Lee R. Brown, who was granted intervener status by Commission order dated October 1, 2004, filed a Motion to Compel Answers to Data Requests, requesting the Commission compel current and former officers and directors of Bridge Hollow Water Association ("Bridge Hollow") to answer the data requests submitted by Mr. Brown in September 2004. In his Motion, Mr. Brown indicated that to date he has received no answers to his data requests from either current or former officers or directors of Bridge Hollow.

On May 16, 2005, the Commission received a letter from Mr. John B. Tebbs to Mr. Brown indicating his willingness to provide any and all information of which he has knowledge from the time during which he was involved in Bridge Hollow's operations. The letter indicated that Mr. Tebbs is not currently an officer of Bridge Hollow.

On May 25, 2005, the Division of Public Utilities ("Division") filed a memorandum recommending that the Commission schedule a hearing and require Mr. Tebbs to show why he is not obligated to comply with the Division's request for relevant information regarding the operation, control and properly authorized voting shares of Bridge Hollow. The Division indicated that the Tebbs family apparently took control of Bridge Hollow from the predecessor developer and had controlled and operated the water company for several years before the current Association began to manage daily operations. The Division noted its understanding that Mr. Duane Fluckinger, Bridge Hollow's current Director, had attempted to procure all documentation and accounting information for the water company for the period that it was managed by the Tebbs family. According to the Division, much of the information sought by Mr. Brown in his data requests to Bridge Hollow relates to that period of time. The Division states Mr. Fluckinger has been very cooperative but that the Tebbs family has ignored the Division's document requests.

Having reviewed all relevant filings, the Administrative Law Judge determines to take Mr. Tebbs at his word and expects all parties, including Mr. Tebbs, to respond as requested to all data requests submitted by other parties to this docket. As these data requests are a valid means of discovery under Commission rules and the *Utah Rules of Civil Procedure*, all parties are reminded that no formal request or order must issue from the Commission in order to lend its imprimatur to such data requests. Failure to voluntarily provide requested information may result in a Commission-issued order to show cause, subpoena to appear and produce documents, or an order requiring deposition of witnesses.

Notice is hereby given that a **Technical and Scheduling Conference** in this matter will be held on **Tuesday, June 28, 2005 at 9:00 a.m.**, Room #427, Fourth Floor of the Heber M.
