Pursuant to Utah Code Ann. 63-46b-9 and Utah Admin. Code R746-100-7, Lee R. and Sheila Brown, Share Holders of Bridge Hollow Water Association hereby move for leave to intervene in the above referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Lee R. and Sheila Brown state as follows:

1. Lee R and Sheila Brown, are owners of Lot #30 in the Bridge Hollow Subdivision that is served by Bridge Hollow Water Association and we are Share holders in the Bridge Hollow Water Association as well as members of Bridge Hollow Home Owners Association.

Our current address is 4963 No. August Street, Erda , Utah 84074.

2. As share holders of record in Bridge Hollow Water Association and home owners in Bridge Hollow subdivision we feel our interests and the interests of other lot owners and share holders in the Bridge Hollow Water Association will not be represented by the current or former Directors and Officers of Bridge Hollow Water Association. We need to be allowed to intervene in order to insure that all relevant information and testimony is provided to the Public Service Commission in order to determine if Bridge Hollow Water Association has been operating as a private water utility without the Commission's authority. We are concerned that the developers of Bridge Hollow Development and the Surry Ridge Ranch at Bridge Hollow and or their successors have operated the Bridge Hollow Water Company in the developers interests rather than the interests of share holders and lot owners who are dependent on them for service.
3. Recent information received since the Division of Public Utilities filed it's Petition for an Order to Show Cause indicates there is potential wrong doing by the former Board of Directors and possibly members of the current Board of Directors which has created benefits for the developers and hidden liabilities for share holders. Only a share holder, such as Lee R. and Sheila Brown, will be able to represent share holder interests in this matter. No party should be disadvantaged due to our intervention and the proceedings should benefit.
