5	JUDGE ARREDONDO: This is a Public Service
6	Commission hearing regarding the application of
7	Canaan Springs Water Company for a certificate of
8	convenience and necessity to operate as a public
9	utility rendering culinary water service, Docket No.
10	08-2498-01. And I'm Ruben Arredondo, the ALJ
11	assigned by the Commission to hear this matter.
12	Notice of this hearing was issued by the
13	Commission October 29th, 2008.
14	So let's go ahead and take appearances.
15	Mr. Hafen, why don't we have you go ahead.
16	MR. HAFEN: Kendrick Hafen, appearing for
17	Canaan Springs Water Company.
18	JUDGE ARREDONDO: All right. Thank you.
19	Ms. Schmid?
20	MS. SCHMID: Patricia E. Schmid with the
21	Attorney General's Office, representing the Division
22	of Public Utilities.
23	JUDGE ARREDONDO: Thank you. And then do
24	you have your witness with you as well?
25	MS. SCHMID: Yes. Ron Slusher from the

- JUDGE ARREDONDO: All right. Thank you.
- 3 So the purpose of this hearing is basically to hold
- 4 the hearing in the application for Canaan Springs,
- 5 application for their certificate.

- 23 Q Mr. Slusher, by whom are you employed?
- 24 A The Division of Public Utilities, State of
- 25 Utah.

- 1 Q In what capacity?
- 2 A I am a data -- or a technical consultant.
- 3 Q And your business address?
- 4 A Is 160 East 300 South, Heber Wells
- 5 Building, Fourth Floor, Salt Lake City, Utah 84114.
- 6 Q Have you been involved on behalf of the
- 7 Division in this matter?
- 8 A Yes, I have.
- 10 prepare or cause to be prepared a memorandum dated
- 11 September 9th, 2008, entitled "Issuance of a
- 12 Certificate of Public Convenience and Necessity
- 13 (CPCN) to Canaan Springs Water Company, Case Number
- 14 08-2498-01"?
- 15 A I did.
- MS. SCHMID: The Division would request
- 17 that this memorandum be marked as DPU Exhibit 1, and
- 18 we would request that it be accepted into evidence.
- 19 JUDGE ARREDONDO: Okay. We'll go ahead and
- 20 accept that DPU Exhibit 1 into evidence.
- 21 (Whereupon DPU Exhibit 1 was received into
- 22 evidence.)
- MS. SCHMID: Thank you.
- Q Mr. Slusher, do you have a brief statement
- 25 that you would like to give this morning?

- 1 A Sure. I reviewed the information that
- 2 Canaan Springs sent in through Mr. Hafen for their
- 3 application on CPCN, and after reviewing the
- 4 information they sent in with their proposed tariff,
- 5 I submitted a memorandum to the Commission that they
- 6 accept their application for CPCN.
- 7 Q You noted that the rates established are
- 8 not sufficient to cover all the expenses. Is it your
- 9 belief that the developer is going to subsidize the
- 10 proposed rates until the company is a stand-alone
- 11 company?
- 12 A Based on the application information, that
- 13 is correct.
- Q Do you have -- is there a question about
- the billing cycle that was left open?
- 16 A Yes. Reviewing this this morning, I could
- 17 not find a billing cycle as to if they were going to
- 18 bill quarterly or monthly, so we need to clarify
- 19 that.
- 20 JUDGE ARREDONDO: Do you know anything
- 21 about that, Mr. Hafen? Did you hear his --
- 22 MR. HAFEN: Yes. I believe -- I'm not
- 23 positive, but I believe the billing cycle is
- 24 quarterly.
- JUDGE ARREDONDO: Okay.

- 1 MS. SCHMID: With that, the Division has no
- 2 more questions for Mr. Slusher and he's available for
- 3 cross examination.
- 4 JUDGE ARREDONDO: Okay. Mr. Hafen, would
- 5 you like to cross examine Mr. Slusher?
- 6 MR. HAFEN: I have no questions, your
- 7 Honor.
- JUDGE ARREDONDO: All right. Thank you.
- 9 Then we'll go ahead and receive Mr. Slusher's
- 10 testimony into evidence, along with DPU Exhibit 1.
- 11 Would you like to add anything, Mr. Hafen?
- 12 MR. HAFEN: No, your Honor. I believe that
- is -- everything has been said that needs to be said.
- JUDGE ARREDONDO: Okay. Thank you. Then
- 15 the Commission will take this matter under advisement
- and issue an order shortly on that CPCN. Thank you.
