If the parties do not reach a settlement, date by which the Division shall file its testimony	Monday, March 15, 2010
If the parties do not reach a settlement, date by which Pine Valley shall file its responsive testimony	Monday, March 29, 2010
If the parties do not reach a settlement, date by which the Division shall file its reply testimony	Monday, April 5, 2010
Hearing	Thursday, April 15, 2010 commencing at 9:00 a.m. before the ALJ, in Room 451, Heber M. Wells Building, 160 East 300 South, Salt Lake City, UT 84111

Pine Valley shall provide notice of the hearing to its customers no later than 15 days before the hearing.

Discovery turn-around time is 20 calendar days for requests served before March 15, 2010, and 10 calendar days for those served on or after March 15, 2010. Parties may move for an extension of time if required.
