By The Commission:

This matter is before the Commission on the bankruptcy of Wolf Creek Water Company. The Commission was notified via customer complaint and notice from Company counsel that Wolf Creek Water Company, Inc. (CPCN 071) had declared bankruptcy. Additionally, during an investigation of the bankruptcy, the Division of Public Utilities (Division) learned that Wolf Creek Water Conservancy, Inc. (CPCN 2417) would be sold to a municipal entity, Wolf Creek Water and Sewer Improvement District (District). Both Wolf Creek Water Company, Inc. and Wolf Creek Water Conservancy, Inc. are regulated by the Commission.

The Commission ordered the Division to monitor the sale and bankruptcy and notify the Commission when the entities were acquired by the District. The entities were sold to the District on January 31, 2011. The Division received proof of the acquisition of the two entities when it received a copy of a bill of sale on March 3, 2011. The two entities will be dissolved on the records of the Utah Division of Corporations and Commercial Code, once certain items are finalized per the order of the Bankruptcy Court.

All of the entities' customers were notified of the transfer of ownership. Since the District is not an entity regulated by the Commission, the Division recommended the Commission cancel the CPCNs for the two entities, i.e. CPCNs 071 and 2417.

Based on the foregoing information submitted by the Division, the Commission finds the CPCNs for Wolf Creek Water Company, Inc. (CPCN 071) and Wolf Creek Water Conservancy, Inc. (CPCN 2417) are no longer required and should be cancelled.

ORDER

1. The Certificate for Wolf Creek Water Company, Inc. (CPCN 071) is cancelled;
2. The Certificate for Wolf Creek Water Conservancy, Inc. (CPCN 2417) is cancelled;
3. Pursuant to Sections 63G-4-301 and 54-7-15 of the Utah Code, an aggrieved party may request agency review or rehearing of this Order by filing a written request with the Commission within 30 days after the issuance of this Order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission does not grant a request for review or rehearing within 20 days after the filing of the request, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a petition for review with the Utah Supreme Court within 30 days after final agency action. Any petition for review must comply with the requirements of Sections 63G-4-401 and 63G-4-403 of the Utah Code and Utah Rules of Appellate Procedure.
